1/44- Read the letters AH/ADMN/VJA/20 and AH/ADMN/VJA/2380A/20, Dt.22-06-2020 of the General Manager, Andhra Hospitals (Vijayawada) Pvt. Limited in which they requested to allot the Auditorium Block of CVR Commercial Complex, Vijayawada for a period of one year to establish a temporary Modern Covid-19 Treatment Centre and assured that they will follow guidelines strictly which were given by the Government as well as the District Administration, Krishna and also adhere necessary requirements. Further, they expressed their willingness to pay rent on par with the existing rent of Andhra Hospital building @ Rs.14.66 per Sft. or as per the R & B Rules and Regulation while hiring the private buildings to Government offices.

Read the G.O.Rt.No.215, HM & FW (B2) Department, Dt.24-03-2020 in which the Government empowered the District Collector and Magistrate to take such measures for taking over of the isolation rooms / wards / blocks / entire private hospital as deem fit necessary to prevent the outbreak of Covid-19 and the spread thereof. Also read the Circular No.Dr YSRAHCT/COVID-19/1365-NP/2020, Dt.10-04-2020 of Dr.YSR Aarogysri Healthcare Trust in which it was directed that non-empanelled private hospitals if declared as Covid-19 hospitals by the State or by the respective District Collector and Magistrate are also eligible to treat the Covid-19 cases under the scheme.

In this regard, while reporting the circumstances, the Government was requested to accord necessary permission to lease the Auditorium Block of CVR Commercial Complex to Andhra Hospitals (Vijayawada) Pvt. Limited, Vijayawada temporarily for a period of one year, subject to fulfilling of conditions and to fix the rent on par with the existing hospital building @ Rs.14.66 per Sft. as per the rates fixed by the Finance (FMU-TR & B) Department in G.O.Ms.No.37, Dt.07-03-2016, whichever is higher.

Read the Government Memo MAU01-CRDAOBJW(MISC)/9/2020-J2 Computer No.1176065, MA & UD (J2) Department, Dt.30-07-2020 in which the Government after considering the request of M/s.Andhra Hospitals (Vijayawada) Pvt. Limited and the recommendations of the Collector & District Magistrate, Krishna keeping in view the increase of Covid-19 cases at a rapid pace and the need to increase bed capacity, issued no objection to the District Collector, Krishna District to requisition the Auditorium Block in CVR Commercial Complex under the Disaster Management Act, 2005 and as per G.O.Rt.No.215, HM & FW Department, Dt.24-03-2020 for taking up any activity for Covid management as he deems fit to handle the emergency situation subject to the following conditions.

- (a) At the end of 6 months, the District Collector, Krishna District shall ensure handing over the premises back to the Municipal Commissioner, Vijayawada Municipal Corporation in the same physical condition in which it was given.
- (b) Rent shall be fixed by the District Collector, Krishna District in consultation with the Council of Vijayawada Municipal Corporation as Council is the competent authority to fix rent.
- (c) In case the premises are given for setting up of COVID treatment facility, 50 percent of the beds should be reserved for Arogya Shree patients.

In this regard, it is to submit that in Krishna District the Covid-19 cases are increasing at a rapid pace and as of now, 6300 active cases are existing. Besides that, the number of deaths are also increasing and creating panic situation. In such circumstances, there is dire need to increase the bed capacity in the District to facilitate the public to undergo treatment for early recovery. Further, the

Government directed that in case the premises are given for setting up of COVID treatment facility, 50% of the beds should be reserved for Aarogya Shree patients.

Read the office proposal for allotting the Auditorium Block in CVR Commercial Complex to Andhra Hospitals (Vijayawada) Pvt. Limited, Vijayawada on lease for a period of 6 months under Disaster Management Act, 2005 issued in G.O.Rt.No.215, HM & FW Department, Dt.24-03-2020 on the requisition of the District Collector, Krishna District subject to fulfilling of the conditions stipulated by the Government and District Administration from time to time in the treatment of Covid-19 and subject to fulfilling of the aforementioned conditions (a), (b) and (c) and on the condition to bear all the expenditure for establishing Covid-19 Treatment Centre and to fix the rent to be collected i.e., @ Rs.14.66 per Sft. on par with the existing hospital building or as per the rates fixed by the Finance (FMU-TR & B) Department in G.O.Ms.No.37, Dt.07-03-2016 i.e., Rs.15/- per Sft.
