PART- I

Information to Bidders

COVER A TECHNICAL PROPOSAL

1) Objective:

The open drains are carrying the solid waste including the floating waste and are an obstruction for disposal of Storm Water. The floating waste is carried along with The conventional bar screens are not serving the purpose and clearing the screens manually at 24 x 7 is not possible and the floating waste is being stagnated at manual screens.

In order to overcome the difficulty in removing the floating waste, the garbage collected at the bar screens shall be lifted mechanically and carried into a truck directly which can be placed either parallel or perpendicular to the drain. The entire screens, lifting mechanism shall be designed in such a way such that manpower is used only for operating the motor and for supervision.

Scope of Work:

The bidder has to plan, design and erect such mechanical Escalator screen with lifting mechanism and for conveying the floating waste into the truck, directly 100% float shall be removed from the channel. The storm water drain channel will be varying from 2.00 to 3.00 Mts. wide. The rotary screens shall be placed across the channel at an inclination and the garbage has to be conveyed to such a height that the garbage (waste) has to be automatically loaded into a truck. The screens shall be in stainless steel SS 304 blade and the supporting frame and escalator double conveyor belt and lifting body platform and footpath platform / channel etc. mounting shall not be other than the stainless steel.

The work includes mechanical, electrical equipment, erection, operation and transfer on turnkey system. The bidder who is awarded with the work shall give the time frame for erection and commissioning of the mechanical screens. The screens shall be designed such that the screens can be folded / lifted during the rainy season such that these will be absolutely free flow of rain water during the rainy season. The channel has to flow to its designed capacity. The machinery install shall be guaranteed and replacement of spares and maintenance shall be done at no cost for 2 years from the date of commissioning.

The civil work shall be carried out confirming to standard specifications, relevant code of IS:456, IS:800 etc., and as directed by the departmental authorities and to suit the shape and size of Multi rake course bar screens, conveyor belt, machinery etc.,

The scope of work also includes civil works such as side wall raising, bed concrete, wall provision etc., as required for comfortable placement of the machine so as to execute the work.

The bidder has to clearly mention the detailed mechanical specifications of the screens and approximate quantities of civil works that fit to fix the screens i.e., grade of concrete with quantities and reinforcement quantity, plastering and finishing etc., so as to assess the cost component of civil work in terms of SSR in vogue.

The civil work to be designed and carried out for withstanding the complete machine load.

2) Eligibility Criteria:

The Contractors having engineering work shops / SSI units and having 5 years of experience in similar field / nature of work.

They have to submit the plan and mechanism in a separate cover as a technical proposal and the cost involved in a separate cover as financial proposal.

The technical proposals will be scrutinized based on the experience and the planning and design of mechanical screens. The bidders who are technically qualified are eligible for opening of financial proposals. The lowest bidder will be awarded the work after meeting the technical aspects / proposals.

The bidder has to give the planning / work schedule and its erection work.

3) Terms and Conditions:

The work shall be carried out precise to the approved plan. The payment will be made as detailed below:

The supplier / bidder are responsible for proper functioning of screen for a period of 5 years. The performance guarantee has to be extended up to 5 years.

II. PREPARATION OF PROPOSALS
