# INTRODUCTION

# 1. Project Background

Vijayawada Municipal Corporation, Vijayawada, Andhra Pradesh is desirous to develop Go karting Facility, Food Courts, Event Arena, play zone, common parking and allied facilities in Lorry Stand Site, Bhavanipuram on Public Private Partnership (PPP) basis. It is felt that such a development shall be complementary to the park and shall provide an alternate attraction to the teeming visitors/ footfalls of the park.

VMC proposes to identify a private partner for Development of Go karting Facility, Food Courts, Event Arena, play zone, common parking and allied facilities in Lorry Stand Site, Bhavanipuram the details of which are mentioned below. VMC invites Expression of Interest ("EOI") from interested parties to assess the market response and to further undertake the process of selection and appointment of "Developer cum Operator on PPP mode".

The present project is proposed to be implemented on Public Private Partnership (PPP) format. Under this format, the private sector shall be responsible for designing, financing, executing, operating, maintaining and transferring the facility to VMC at the end of concession/authorization/lease period.

# 2. About Vijayawada


Vijayawada is a city on the banks of the Krishna River, in the Indian state of Andhra Pradesh. It is a municipal corporation and the headquarters of Vijayawada (urban) Mandal in Krishna district of the state. Vijayawada is one of the rapidly growing urban markets of the country. The sectors that contribute to the City economy are construction, education, entertainment, food processing, hospitality, registrations, transport, etc. Based on the recommendations of the Sixth Central Pay Commission, it is classified as one of the Y-grade cities of India. The GDP of Vijayawada in 2010 was \$3 billion and is estimated to touch \$17 billion by 2025.

Vijayawada Municipal Corporation is the civic governing body of the city. It was constituted on 1st April 1888 and was upgraded to selection grade municipality in 1960 and finally to corporation in the year 1981. The jurisdictional area of the corporation is spread over an area of 61.8 km2 (23.9 sq. mi) with 59 wards.

#### 3. Site Features

#### 3.1. Location

- Important city parks in Vijayawada, Located in prime locations of Vijayawada with convenient accessibility through Public Transport.
- The site is located at ~3.2 km from Vijayawada Municipal Corporation office & ~24 km from the Vijayawada Airport, ~4 km from Vijayawada Main Bus Stand, ~4.9 km from Vijayawada Railway Station.
- Area Approximately 3 Acres



#### **DEVELOPMENT OF THE PROJECT**

The scope includes Design, construct, supply, installation, commissioning and operation and maintenance for about **5 years** (this period may vary at the time of RFP) of proposed Project with allied facilities at Lorry Stand, Bhavanipuram, Vijayawada under Design, Build, Finance, Operate and Transfer (DBFOT) mode.

In accordance with the ensuing RFP, the selected Developer cum Operator/ Concessionaire shall be responsible for making the facility developed for the intended purpose while performing all its obligations covered under the Concession Agreement in its entirety.

Scope also includes, but not limited to, developing required specifications, and

construct/ develop in accordance with the same, quality assurance & quality control and required corrective actions.

# Project Components, under Essential Facilities, to be developed include:

- (a) Go karting Facilitates
  - i. Go Karting track minimum length of 400 mts, width 7m
  - ii. Ticket Counter with centralized ticketing system
  - iii. Parking for Visitors
  - iv. Toilet Block
  - v. Paddock (Parking) for Go karts
- (b) Food Courts minimum 8 units inclusive of sitting/dining space
- (c) Flea Market
- (d) Play Zone
  - i. Cricket Court
  - ii. Sand Volley ball etc.
- (e) Convention Hall
- (f) Guest Rooms
- (g) Common Infrastructure Parking (2-wheeler & 4-wheeler) & Roads
- (h) Admin Office

# Other Obligations:-

- o All the Project Facilities shall adhere to the Environmental / Eco Friendly Guidelines or other relevant guidelines.
- o Develop the projects to the maximum extent using the existing contour levels
- o Retain the natural drainage characteristics;
- o Incorporate Energy and resource efficient designs;
- o Maintain Plastic Free Zone;
- o The Project shall be user friendly and provide eased access to differently abled persons to all the project facilities in accordance with "Persons with Disabilities Act, 1995" with subsequent amendments and 'UN Convention for Rights of Persons with Disabilities (UNCRPD);

- The Applicant should have average annual turnover of Rs. 10 crores in the last three financial years (FY 2016 2017, 2017 2018, 2018 2019) and;
- The Applicant should have minimum net-worth of Rs. 2.5 crores in the last financial year (FY 2018 2019).

# **TECHNICAL CAPACITY**

The Applicant / Consortium (with members in Consortium limited to two firms) should have following minimum experience mentioned below

- Project experience of operating / developing at least one Go carting/ Amusement Park/Entertainment facility/ Sports facility/ Recreational facility for a minimum period of 12 (twelve) months in the last 3 (three) financial years.
- As part of Technical Capacity, applicants are expected to make a presentation to the authority on the following aspects of project development.
  - Concept Details of Project type to be taken up in the site.
  - Conceptual Plan
  - Proposed Activity Mix
  - The estimated project cost (Broad Costs)
  - Detailed Financial Feasibility Study
  - The proposed revenue generation strategy for the project.
  - Project Portfolio of the applicant
