PARTICULARS OF RECIPIENTS OF CONCESSIONS, PERMITS OR AUTHORISATION GRANTED BY THE PUBLIC AUTHORITY (SECTION 4(I)(B)XIII)

13.1 Description of the activity of recipients of benefits.

SOCIAL SECURITY PENSIONS:

Payment of Rs.200/- as monthly payment to Old Age, Widow, Weaver pensioners and Rs.500/- to PHC pensioners.

ELIGIBILITY:

OLD AGE PENSION:

1. Must have more than 65 years
2. White ration card
3. Age proof supported either by ration card or voter identity card.

WIDOW PENSION:

1. Death certificate of husband
2. White ration card

PHYSICALLY HANDICAPPED PENSION :

1. Medical certificate of 40% disability or above.
2. White ration card

WEAVERS PENSION:

1. Certificate of practicing the weaving profession.
2. White ration card

NATIONAL FAMILY BENEFIT SCHEME:

Payment of Rs.5000/- to the families on the death of the bread winner of the family in the following order of priority.

1. S.C./S.T. families,
2. Families with orphan children
3. Families with disabled children
4. Families with single girl-child
5. Families with single child
6. Families belonging to minorities and B.C./O.C.

ELIGIBILITY:

1. Death certificate of the head of the family.
2. The children of the family should be below 18 years.
3. They should be no earning member in the family.
4. The death should not be due to accident or suicide.
5. The family members should not be the beneficiaries of any other welfare schemes.

ABHAYAHASTAM:

On enrollment in the scheme by payment of Rs.1/- per day (Rs.365/- per an year), and Rs.35/- towards service charges, the member would be paid a minimum amount of Rs.500/- and a maximum amount of Rs.2118/- towards monthly pension and the children of the members would be paid an amount of Rs.100/- per month towards scholarship if they are students of 9th 10th and Intermediate.

ELIGIBILITY:

1. Must be a member of SHG and the length of membership should be one year and above.
2. Must have white ration card.
3. The age of the member should be between 18 to 50 years.
4. Pension would be sanctioned on completion of 60 years.
