Special Committees :

VMC is consisting with 64 elected Ward Members. 11 No.of Special Committees are formed by the Council. For each Special Committee, one Ward Member will be elected as Chairman and another Member will be elected as Dy.Chairman. The duties of Special Committees are noted against each:

Sl. No.	Name of the Special Committee	Duties of Special Committee
1	Finance, Audit Special Committee	Income and expenditure of VMC, collection of all categories of taxes, charges, cess, fees, rents. Repayment of loans, receipt of Grants, monitoring of savings, supervision of internal audit.
2	Integrated City Development Special Committee.	Designing of resources for various development schemes, monitoring & implementation of various schemes etc.,
3	Water Supply, Under Ground Drainage Special Committee.	Construction of drinking water reservoirs, replacement of old and damaged pipe lines, extension of water supply facility to all areas. Providing public taps, sufficient water supply, extension of UGD Scheme to all areas, it's maintenance etc.,
4	Education, Cultural Activities Special Committee.	Schools committee, toilets, drainage facility, libraries, reading rooms, inter- school competitions, improvement of education standard etc.,
5	Sanitation, Health Special Committee	All issues relating sanitation, inspection of Health Centres, supply of medicines, staff, conduct of free health camps in schools, providing of toilets in each schools, prevention of open defecation, urination. Providing public urinals, toilets in all public places.
6	Sports & Traffic Special Committee	Conduct of Youth Festival, development of play grounds, improvement of sports facilities, naming of streets, areas, development of junctions etc.,
7	Slum Improvement Special Committee	Identification of slum areas in the city, control, designing of development activities, rehabilitation of poor people evicted from the encroachment areas, issue of house site patta to them.
8	Women Welfare Special Committee	Supervision of all Urban Community Development activities, activities of DWACUA Groups, sanction of pensions, i.e., Widow, Old age, Physically Handicapped pensions, distribution of pensions.
9	Roads, Drains, Bridges, Flyovers, Buildings Special Committee.	Development of roads, drains, proposals for Bridges, Flyovers, Out-fall drains, supervision of construction activities etc.,
10	Lighting, Parks Special Committee	Protection of Parks, proposals of new parks, improvement of greenery, supervision of lighting, providing high mast lights, plantation in hill areas etc.,
11	Public Grievances Special Committee	Review and redressal of public grievances etc.,
